Adopted 2017 - 2018 Budget Calendar – Draft – June 27th Adoption**

January 12, 2017 <i>Thursday</i>	School Board Meeting – Adopt 2017 – 2018 budget calendar.
February 16, 2017 <i>Thursday</i>	Board to establish budget priorities.
February 21, 2017 <i>Tuesday</i>	Budget materials submitted to principals and supervisors.
March 10, 2017 <i>Friday</i>	All budget pages due from principals and supervisors.
April 27, 2017 <i>Thursday</i>	Publish first NOTICE OF BUDGET COMMITTEE MEETING. <i>ORS 294.426</i> (five to thirty days before budget meeting)
May 4, 2017 <i>Thursday</i>	Publish second NOTICE OF BUDGET COMMITTEE MEETING. <i>ORS 294.426</i> (five to thirty days before budget meeting)
May 5, 2017 <i>Friday</i>	Proposed budget available to the public.
May 11, 2017 <i>Thursday</i>	FIRST MEETING OF THE BUDGET COMMITTEE – (Brixner) Presentation of the budget message by the executive officer and the proposed budget by the budget officer. Public Input; Budget may be approved at this meeting.
May 26, 2017 <i>Friday</i>	Submit “List of Planned Public Improvements” to BOLI (30 days prior to budget adoption)
May 18, 2017 <i>Thursday</i>	SECOND MEETING OF THE BUDGET COMMITTEE – (Brixner) This meeting will be held only if the budget is not approved on May 11 th .
May 25, 2017 <i>Thursday</i>	THIRD MEETING OF THE BUDGET COMMITTEE – (Brixner) This meeting will be held only if the budget is not approved on May 18 TH .
June 20, 2017 <i>Tuesday</i>	Publish NOTICE OF BUDGET HEARING, FINANCIAL SUMMARY, ETC. (ED1), (Not more than 30 days nor less than 5 days prior to budget hearing) <i>ORS 294.438 through ORS 294.441</i>
June 27, 2017 <i>Tuesday</i>	PUBLIC HEARING ON THE APPROVED BUDGET: shall be conducted by a quorum of the Board.
June 27, 2017 <i>Tuesday</i>	SCHOOL BOARD MEETING. Enact resolutions adopting the budget, making the appropriations, categorizing and declaring tax levy. <i>ORS 294.456</i>
July 14, 2017 <i>Friday</i>	Deadline to certify the tax levy to the county assessor and file a copy of the resolution adopting the budget with the Oregon Department of Revenue. <i>ORS 294.458</i>
